## Cosway New Zealand Leader Centre – General Information

### Purpose

To assist an Independent Business Owner [IBO] in developing his/her network in the following areas:

- Signing up VIP shopper or IBO
- Product availability
- Product and business opportunity training

### Qualification

#### Requirement

- This privilege is open to all active Independent Business Owner (IBO)
- Must be a New Zealand Nationality or New Zealand Permanent Resident (PR).
- Agrees to operate under own or rented property.
  - All operational expenses including rental, computer (both hardware and software), printer, internet facility and utilities but no limited to the above shall be borne by the IBO.
- The Leader Centre [LC] shall have a reasonable place to conduct meeting and training on product and business opportunity.
- Must be able to attend training, at your own cost, at Cosway New Zealand Ltd or any other venue as advised by the company on “Point of Sales’ [POS] System and other related matters in managing a Leader’s Centre
- Security Deposit
  - A non-interest refundable guarantee deposit of NZ\$ 5,000 is required.
  - The value of product (at retail price) including IBO and VIP shopper starter kits to be consigned shall, at any one time, be not more than **four** times the amount of the guarantee deposit.

### Other Terms and Conditions

- LC Operator is non-transferable to any other IBO.
- LC Operator shall not be treated as an employee of eCosway.
- Operating hours shall be determined by the Leader Centre.
- The LC premise shall be in a clean and safe environment.

- Inventory on Display and storage shall be in an appropriate location and placed in a cool place and not subject extreme temperature at all times.
- All sales and promotions shall be in accordance with the company's current promotion.
- Leader Centre operator is allowed to order goods twice a week with a minimum order of NZ\$1,000 for each order.
  - Products classified as Food is not to be included in the inventory order placed. However, those wishing to apply for sale of products classified as Food, any such goods placed by LC Operator shall not be exchangeable or refundable
- The securing of Business License or any other related permit (if required) shall be the responsibility of the LC Operator.
- eCosway signage is not allowed to displayed in the premise.
- A Leader Centre shall not be within 30KM vicinity of an existing Leader Centre.
