



# CRITERIA FOR COUNTRY FARM ORGANIC STORE APPLICATION

Applicant applying for the Country Farm Organic Store Operatorship **MUST** fulfill the following requirements:

- 1. A registered eCosway Business Owner (BO) (male/female).
- 2. Computer literate.
- 3. Able to fulfill all the standard requirements under the Country Farm Organic Store Interview Programme, including passing the Verbal Assessment and successfully completing the Product Training, Point Of Sales (P.O.S.) Training, Practical Training and satisfactory completion and submission of all necessary legal documents.
- 4. Able to communicate well in English. Ability to converse in other languages is an added advantage.
- 5. Knowledgeable and passionate about organic products. Willing to commit and work on the business full-time.
- 6. Willing to perform cooking demonstrations, when needed.
- 7. Able to provide **CASH DEPOSIT** as below:-
  - ✓ For Malaysian applicants : RM10,000
- 8. Able to provide GUARANTOR(S). (Kindly refer to Page Two (2) for 'Guarantor Guidelines'.)

# **GUARANTOR GUIDELINES**

The proposed guarantor can be a salary earner, self employed or eCosway / Cosway Member.

# **GUARANTOR'S BASIC INCOME REQUIREMENTS:**

Proposal For ONE (1) Guarantor:

A person with income of at least RM5,000.00 per month

Proposal For TWO (2) Guarantors:

2 person(s) with income of at least RM3,500.00 each per month

### Documents REQUIRED From Your Proposed Guarantor(s):

### Salary earner

- ✓ Photocopy of NRIC
- ✓ Latest 3 months' salary slip
- ✓ Latest 2 years' EA Form / Personal Income Statement issued by the Company
- ✓ Latest 2 years' full set of BE Form / Personal Income Tax Form with receipt of payment <u>AND/OR</u> latest 2 years' EPF Statement

#### **Self-Employed**

- ✓ Photocopy NRIC
- ✓ Company Ownership Statement (ROC / ROB)
- ✓ Latest 3 months' bank statement of guarantor's company
- ✓ Latest 2 years' of Profit & Loss Statement of guarantor's company
- ✓ Latest 2 years' full set of B Form / Personal Income Tax Form, with receipt of payment.

#### Cosway / eCosway member

- ✓ Photocopy NRIC
- ✓ Membership account number

#### IMPORTANT NOTE:

- The Guarantor(s) must be financially stable including free from any summons, legal action, bankruptcy etc. and not above 50 years old.
- The proposed guarantor shall **NOT** be the same person who stands in as a guarantor for other Stockists.
