

## eCosway VIP Shopper Online Registration Guide

Please note that eCosway VIP Shopper online registration on [www.ecosway.com/US](http://www.ecosway.com/US) is only available for people who are currently residing in the United States of America (USA). If you are not residing in the USA, you cannot register online here.

Please follow this step-by-step guide.

### Consent to Electronic Record
